Product identification and traceability

Each product can be uniquely identified using the information provided on the product label, packaging, or its documentation. Identification data may include in particular:

- product type / model name
- size (if relevant)
- serial number or batch number
- year of manufacture / expiration date (if relevant)
- other information depending on the product type

This information is used for proper product use, record keeping, inspections, and potential handling of complaints or safety incidents.

Safety information for customers
